Dear Judge Jacobson,

I'm hoping you can help me with a problem that has arisen from case no. 09 OP 58.

Patricia put an order of protection on me. Patty left the Woodhaven real estate tax bill in my mailbox. The mail carrier stuck a note to it (See exhibit I). I mailed it back to Patty with a note (See exhibit II.) Patty had Kayla give it to me at Natalyn's 8<sup>th</sup> grade graduation with writing on the envelope. (See exhibit III.) They kept Natalyn away from me at graduation so I took Natalyn's card, with \$50 gift inside, and the tax bill to the house. They would not answer the door, so I left both between the doors and left.

Prior to this, in March 2009, we listed the Woodhaven property for sale. The personal property at the camper was to be sold and the proceeds split. At listing, I asked to be reimbursed for one year's taxes and dues (April 1, 2008 through March 31, 2009), as I had already paid 100% of two years taxes and dues. (See exhibit IV, A & B, and V.) Woodhaven called me and said she had called them and wanted me to clean the toilet, she had cleaned everything else out. The realtor told me that Patty had told her that she (Patty) had sold the belongings to some friends at work and people driving by. I went out to Woodhaven, and the camper was empty. I called Patty and she said I had no friends. I told her all the neighbors stayed in touch with me, and now they know why I never owned a gun. I've outrun a butcher knife lots of times, but I cannot outrun a bullet. I told her that my life insurance wanted to put a stipulation that if I died, she had to prove she didn't do it, and that I had told them, that I had enough people briefed and were watching so that if something happened, they knew who to blame.

For years, Patty always said, "You don't want to get in the middle of woman's world." She always threatened that if I tried to divorce her she would take all that I have. She would say I'll just tell the judge I'm just a poor little housewife, I don't know anything your honor. She said she would do what Mary (ex-sister-in-law) did to Gerry (my brother)--Mary said that their kids were in college and got money from Gerry and they weren't in school.

Now we come to the problem at hand. I received a threatening letter in the mail. (See exhibit VI, last paragraph.) She talks about “distance”—I was at NIU to be in the audience at Natalyn’s band concert. For your clarity, the first paragraph refers to when I overpaid a bill on purpose, and asked her to check her records. (See exhibit VII, A & B). She gets these ideas from her dad. I met her parents on the road on a Sunday, I got exhibit VI on Tuesday in the mail. Her dad has always been one to see what he can get for himself. (See exhibit VIII A & B).

Your honor, here’s the problem. She does things and then turns it around and blames me for it. In the order of protection, she said I harassed her about paying the bill and that I had people lined up to kill her. She put an order of protection on me in 2007, when I showed her a page of my notebook. (See exhibit IX-2 pages) When I filed for divorce she threatened me that I had better drop it. Patty said to me “I told my attorney, ‘Pete won’t lie’. And she {Patty’s attorney} says ‘this will be easy.’” So, your honor, you can see that Patty has been allowed to lie and make any accusations she wants against me. I have not had a visitation with the kids since you started this in June 2009. I’m looking for your help. What are we going to do?

In order to view Personal Property, the Prospective Buyer will have a Designated Agent with them.
17. Although the Seller is listing the Seller's Property in its present physical condition ("As Is" condition), Seller understands that Seller may be held responsible by a Buyer for any latent or hidden and undisclosed defects in the Property, which are known to the Seller, but which are not disclosed to the Buyer.
18. If Seller withdraws the Listing prior to the expiration of the Listing Period, the Seller agrees to pay Broker \$0.00 for advertising and marketing expenses.

We went to a marriage counselor on 10/31/06 (last week) I didn't talk - I said I was meeting on my own. This is a separate documentation of that meeting.

I told him Patty has always threatened me, said if I divorce her she would get everything. Told about night of rehearsal dinner, I left her house and song came on radio, "she got the gold, I got the shaft", and had told Patty that. She had told me I had better remember that. She has always said "I was born to be babied." Told me if I try to divorce her she will play the part of a poor little innocent housewife, and she will get everything.

Told him about calling the cops on her for throwing things at me and how she said I should have just divorced her instead of embarrassing her. She has said she will ruin my reputation, she'll call the coach and Teen Turf and tell them I'm a pedophile.

Counselor said to divorce her and cut my losses, the courts are slanted towards the woman. The longer it goes the more she will get and not earn it. He said look at scar on his forehead, his wife did that with a 2x4 and that is why she was his ex-wife.

Told him to read page 1 & 2 of my notebook. He did and asked if I thought she was serious I said yes, but if she starts something I would finish it.

I asked him to call her and try to talk her into filing. He said he would call, but was sure she wouldn't do it because she was controlling everything.

He asked why I kept notes, I told I had been at a business and some guys were sitting around a table talking about a local person to that area that had committed suicide. They were saying that usually the spouse is a suspect. So I knew she could put on such a good act in public, that if something happened I would be accused. So the notes go back to the 1980's.

I asked if he could come to court and testify if she does file. He said no because of doctor - patient confidentiality. Both would have to agree to let him in. He said don't put anything of our meeting in my notebook, because if something does start, and she knows I have notes, she will subpoena my notebook, and see notes of our meeting, she wouldn't let him in. That is why this is on separate sheets of paper and not in my notebook.

He asked about Patty's family - I told him about how her dad is always out for himself. He worked at Barber Greene and it was sold a couple of times. I told him it would close, he said as long as he got out of there he didn't care. It closed before he was ready to retire. I went with him to sign up for S.S. and he was mad when he found out what it would have been getting if he could have worked to age 67, and not 63.

Told him about her dad used to talk about guys at work who were always getting hurt. And then he had 3 work comp. claims at the same time.

First claim was a forklift backfired and hurt his hearing, another guy next to him wasn't hurt. He was getting a truck bed topper and wanted us to pick them up @ Big Rock and go to dinner in Sugar Grove while truck was being worked on, he said he was getting a nice one because he wasn't buying the insurance company was. Patty was expecting and couldn't get in back seat (2 door car) so they sat in back with our 2 year old between them. She asked him something softly and he heard her and answered even with a talkative 2 year old. After we dropped them back off, Patty asked if I noticed he heard her when she talked soft; said he was faking, he wore a hearing aid until case was settled.

The second time some men were moving a piece of equipment at work, and he said a door came down on his head. I was in his back yard with him and a neighbor who had got hurt at home and had a tingling in his elbow and his small finger on his right hand. Her dad said "yes that is what I have," he had a little surgery on his neck. I knew where he was getting his symptoms from.

The 3<sup>rd</sup> incident, he unplugged the fresh air line on his spray painting helmet, dragged the hose through a solvent, and hooked it back up. They rushed him to the hospital, because they thought he had a heart attack. By the time we got to hospital they had figured out what he had done. He said his buddy, Mike Boone, just happen to have had the data sheets on the solvent on his desk( how convenient ). He said this is going to be the best one yet.

I asked if he had ever heard the phrase, "I didn't know why mom liked burnt toast and chicken wings until I became a mom." That is not Patty. When I cooked meat she took the center cut chop or cut the steaks open to get the one done as she likes it. If we were at a meeting and they set steaks done in front of us, she would have me cut mine and she would take the one she wanted. He said he never ate many steaks. Patty always said "all we ever have is steaks and pork chops." I don't think he felt sorry for her, but I can't make casseroles and such. Next I mentioned about when we went to Chicago with the kids. It was my idea and I made hotel reservations and set up the trip. When we got up that morning she said this is your project you get the kids ready, and I did and she was the first one in the van ready to go. I was so busy that when we jumped out at the train station I realized I still had on my house slippers. After that the kids called them my Chicago shoes, they didn't realize that I was the one to do everything that morning.

Talked about when I donated blood she would say that I had wasted 2 hours that I could have spent with her. She is the one who had had 6 hospital stays in 7 years. Then the 4-H fair had a blood drive and she was on fair board so she donated. I told him that she told about everyone at the fair to go donate because she did.

I got home from my meeting with the counselor and Patty asked how it went, I told her he was also married to a abusive women. Told her that his wife had put the scar on his forehead with a 2x4 and that is why she is the ex-wife. She said she couldn't believe he told that, she said wait till she talks to him again. I didn't let on that she would be talking to him.

Got home. Patty said , counselor called and she chewed him out for telling that me he was also beat by his wife. She was proud of tearing into him.

I feel it is time for me to tell what is going on with Patty and I. It started in October of 2005 when I called the cops on her for throwing stuff at me, as she had done for years. She had told me to be home at 5 because supper would be ready. Now we don't usually eat at 5, usually I got home and helped with supper. So when I walked in at 5:30 she started throwing again. She even has the kids trained to hand her something and say "here throw this at him." When the cops got there I was a little embarrassed and told them I only called because I had heard if she files for divorce this would look bad on her. How does a guy tell the cops she has been beating him up for 20 years. All evening she kept saying it was her fault and asking for forgiveness. So the next day she said we needed to go talk to someone. We went to our clergyman and told the story. He asked her what am I doing wrong? I come home after work and was helping out a neighbor as the bible says we should. When we got home she accused me of calling ahead and telling him to side with me, and she said he only sided with me because I am the bread winner and can put more in the collection plate.

So time went on and things weren't getting better. She demanded an apology from me because she said it was all my fault. She said I had exposed her to everyone, and she had everyone fooled until I called. I had warned her for years I was going to call the police on her. In the spring of '06 I was asked to help out at track meets, and I also help some at Teen Turf. I have always said a man is guilty until proven innocent, and never put myself in comprising circumstances. At this time the Duke University's lacrosse team was accused of raping a dancer, and I said those guys are sunk they will be ruined for life. So you can imagine how concerned I was when we were coming home from Dixon on an errand and she says "I am going to destroy you, I'll tell the coach and Teen Turf that you are a pedophile you will be done! This didn't make me like her any better.

On June 18 she was fishing at Woodhaven with Mathew, and I showed up. She said since I was there she would go home. When Mathew and I got home she told me there had been a guy named Phil from section 3 there and he had a 9 year old and would be back next weekend. After Phil left she said an older man fishing said he thinks you're available, and she said she told him "who says I'm not." The following weekend she said she was going out to see if her parents were there. When she got back she said she had swung by the lake, but Phil wasn't there. She said if he had been, they would've ended up at our camper. So I called Woodhaven and asked for the address of guy named Phil in section 3. I got his phone number from information, and put his name and number on Patty's pillow. Was she mad when she came out of the bathroom after one of her hour long soaks with a wine cooler. She told her friends I had done this, and they couldn't believe it. I asked if she had told them she went back to look for him, and she said no they wouldn't like that

She told her parents in August about what was going on. They were at our house a little later and I kept my distance. Kayla was at play practice and called to be picked up. I said I would go, but Patty said no her mom and she would. Her dad comes into the room I am in and says "boy let me tell you that you don't want a divorce. You will pay alimony, maintenance, child support, put her through school, all attorney bills, this house will be sold, and she will get her half and we will keep taking you back to court until your broke. You can't handle three kids, why she is gone right now." I said that was her first trip all week. I did all the other play practices, two trips for jazz band. picked up from art club and from science club. Talk about a parent being one sided. Reminds me of when his son got caught using his car to pull out the Shabbona superintendents bushes. That was the neighbors fault, because he shouldn't have been looking out the window at 2:00 a.m. I don't know whose fault it was when he brought home the guys mailbox, but Patty's dad went and threw it in the Kishwaukee River in the middle of the night.

On October 28 I get home from work and she says her dad will pay for her divorce and buy her a house. She had looked at a house in Amboy and called the realtor, and he was a real nice guy. She told him how bad I was and he was just so nice. She said he was turning her over to someone else in the office because he wanted to meet her, and that someone was coming to appraise the house the next week.

After that her parents and her would have little meeting when they were over. This brings us to Christmas. We had decided not to buy each other anything, but she bought me a top coat and I got her a certificate for a kitchen party. She and her parents head of into another room, I go in and say we weren't getting anything for each other. My 10 year old says "Dad you can't win, it's their daughter, they will never agree with you." I base my life on truth and honesty, wish everyone did.

Now we come to Dec. 27, 2006 Kayla wants to go to the school for a basketball game. I go to pick her up at 4:30 and she's not there. The kids said she left out the front awhile ago with her boyfriend. I circle the school and find her in my vehicle. She claims he wasn't there, she says he is at a wrestling tournament in Eureka, so I pull up in front and go in and ask the kids in front of her. She gets mad and calls them all sorts of names. When we get home she runs in ahead of me yelling "mom you won't believe what dad did now." Patty says you know your dad never trust you. I ask Kayla for her cell phone so I can get his parents phone number and find out where he is. She wouldn't give it to me, then she claimed to call, and said no answer. As she went to go down the hallway past me she hit me in the groin. I grabbed her left upper arm. Patty ordered Kayla to give me his parents number. I called and asked if he was there, they said no he is at the high school. The look on Patty's face, priceless. The next day, Patty goes and visits with her parents in Shabbona and then there are several calls back and forth after that. On the 29<sup>th</sup> when supper was ready I went to Mathews' room and told him supper, he didn't come. I said you have the count of three, but still no Mathew. Patty yelled "Mathew now" and he came. I asked why he came when mother calls but not me, he said "she's the one that hits us." I looked at her and smiled, she had a oops look on her face. That evening more calls to Shabbona. I knew something was up, so I changed the lock on the office door Saturday morning. That afternoon her folks came over and took the kids with them. We were suppose to go do something together, she told me I had better straighten up or else. I had kept notes of her behavior and showed her pages 1 & 2 of my notebook. There was an incidence back in 1993 when she was coming home from her parents and going to kill me. I had the pick-up headed out the drive, and when she came after me with a knife I ran and jumped in and took off. I called the hospital to see if a nurse we were close with was on duty, but she wasn't. The nurse wanted to send police out to get Kayla out of the house, but I said no. They called the nurse I wanted, and she called my cell, I just stayed gone for awhile. Patty was a little surprised at what I had. (the notebook is 60 pages and growing). Sunday afternoon I forwarded an e-mail with all my family's addresses on it to my work computer. Her parents brought the kids back and had a private meeting with her. On Monday (New Years Day) I painted a kids bedroom while they all went shopping, I kept my distance because there was more calls to Shabbona. On Tuesday I got a haircut and said cut it short I don't have time to come back. That afternoon Patty took the picture of Kayla's bruise on her arm and to an attorney and put an order of protection against me. I didn't take pictures of my groin, but I have had my hernia fixed.

I had a three week order of no contact., then we showed up for court. They wanted me to make a deal, and I said no way. I wanted to get on the stand and tell she had threatened to try to report me as a pedifile. Also that she watches C. S. I. and said she would get away with it because they would never find my body. She would have her cousins come up from Kentucky, do me in and drive my pick-up into the Ohio River on the way home. They would be home before anyone ever missed me, and she wouldn't report me missing.
