

Bishop David Malloy and Pope Francis,

Pope Francis has called a synod of Bishops this fall to discuss family values in particularly the increase in divorce rate. I would like to comment on why I feel this has happened. Women have been given all the power in the court system and the courts hand them everything. I was threatened by my wife and now ex-wife that she was in charge and I better not get involved with women's world and she would take me to the cleaners. As I left her parents' house after our rehearsal dinner the night before our wedding the song about "she got the gold and I got the shaft" came on the radio. I told her about that on our honeymoon and she said "That's right and you better not forget it." I almost went to the priest when we got back to see about having it annulled immediately but didn't want an "I told you so". She has always said she would kill the kids before I got custody, would tell the kids she brought them into the world and she would take them out and the judge gives her custody. What is wrong with this picture?

She puts an order of Protection on me a few years ago and then had it extended for another two years and the judge went along with this. During the hearing of the extension, I explained to them my work had bought me a new company vehicle in 1987 so she could ride with me on errands and they thought that may keep her calmer. When I said we could not really afford a new pick-up at that time the Vice-President responded it was cheaper than replacing the manager. They knew she was not all there and wanted to keep me safe. The V-Pres. used to say when someone has a broken arm you put a cast on it, but when they are off in the head the fix isn't so easy. In the summer of 2013 she tried an Order of Protection again and I hired an attorney, and we got a different judge. The Attorney asked her what has he done that you had put the past order of protections on him. She said, "Nothing I just want one." The judge in the past had been going along with it.

She always said if the kids don't respect her then they have to be afraid of her. She said the kids never listened to me because I never beat them. She had said she can just accuse me of anything like molesting our two daughters and I will rot in jail, she would say "I will always get my way."

She always threw items at me and I never once raised a hand to her. One time she was even hitting on me and said, "Come on lets go a few rounds." In about the fall of 2005 I called the police on her but didn't press charges. It is kind of embarrassing to have everyone know your wife beats you up. After that we met with our local priest and he told her I was doing nothing wrong and she needs to change her ways. Well I got accused of calling him ahead of time and getting him to side with me she called it a good old boys' club.

We have given women all rights, it isn't 50/50 anymore. So this is a problem I see for the Catholic Church, anything you say will be picked apart by women saying the men are just picking on them. I hope to discuss this further with you. I will come to Rockford or Rome to help solve this problem.

She would watch a television show called Crime Scene Investigators and said she was taking notes and that she would get away with it as they would never find my body. Then in court then she says she has access to a gun if she needs to use is as if I am the dangerous one. Last month a friend from Wisconsin told me that in the 1980s his wife always told him she was going to get him, kill him and how she was going to do it. When they got divorced she also played the, "I'm the one in danger" card.
